# **Turre**

€200,000

Large townhouse for sale in Turre, Almeria, Andalusia on a corner plot and distributed over three floors including a basement and two terraces.

#### Overview

This large property is on the edge of Turre town but within a couple of minutes' walk of supermarkets, shops, banks and restaurants. The views are mainly over the countryside with no buildings on one side. The property consists of 3 levels: large basement with a window, ground floor and first floor with 5 bedrooms and 2 bathrooms. There are two terraces, both covered, one is at the entrance level and the other on the first floor.

#### Layout

Ground floor: Entry to the house is via a pedestrian gate that takes you up a few steps to a covered porch with space for chairs and to the front door. Going through the front door, is a large hallway leading to all the rooms on this level. There is a spacious independent kitchen fully equipped and fitted with electric hob and oven, dishwasher, ceiling fan and fridge-freezer as well as plenty of room for a breakfast table and chairs. A door from the kitchen leads out to the utility patio with washing machine. The sitting - dining room has a wood burning stove and is very light. There is one double bedroom with fitted wardrobes and a bathroom with a walk-in shower.

First floor: There are four bedrooms on this level, 2 with fitted wardrobes and 2 with free standing wardrobes. Two bedrooms have double doors leading out to a covered terrace with views of the countryside and the other two have access to balconies. There is a full bathroom on this level with bath and walk-in shower, bidet, and toilet.

Basement: This is accessed via internal stairs and is the size of the whole house. There is a window for natural light at one end.

Sale includes: Fully furnished. Alarm. Pre-installation of central heating. Roller blinds on all the windows. Wood burning stove.

Turre town, very close to the shops as well as plenty of bars and restaurants.
